INSURANCE ENTERPRISES ACTIVITY REFERENCE YEAR 2006

The General Secretariat of the National Statistical Service of Greece announces results regarding basic financial figures of the insurance enterprises for the reference year 2006, as well as respective comparative data for the reference year 2005. The relative information is collected from a census survey, conducted according to the EC Regulation 58/97/Annex 5 of the European Union. In the frame of this survey, all greek and foreign insurance enterprises having independent insurance activity in Greece during the reference period are invited to provide data. The response rate is approximately 100%.

From the tables that are presented in this release, it results that during the year 2006, compared to the year 2005, the <u>total number of persons employed</u> in the insurance enterprises **has been decreased 6,4%**. This change comes from respective decreases in both the greek and the foreign insurance enterprises (*Table 1*).

The personnel costs are in total raised the year 2006, compared to the year 2005, with rate of change 6,1% for the non-life insurance enterprises and 5,0% for the life insurance enterprises. The personnel costs in both the greek and the foreign insurance enterprises reveal mixed trends. Specifically, in the non-life insurance sector the personnel costs are increased 7,3% in the greek enterprises and decreased 3,6% in the foreign enterprises, while in the life insurance sector they are respectively decreased 0,5% and increased 14,5% (*Table 2*).

Regarding the change of the <u>reinsurance premiums</u> of the insurance enterprises for the year 2006, compared to the year 2005, there is an **increase of 2,3%** in the non-life insurance sector as well as a **decrease of 3,5%** in the life insurance sector. In the individual changes, there is declining trend of the reinsurance premiums in the non-life insurance sector of the greek enterprises and in the life insurance sector of the foreign enterprises, whereas the reinsurance premiums in the life insurance sector of the greek enterprises and in the non-life insurance sector of the foreign insurance enterprises are increased (*Table 3*)

The comparison of the <u>gross premiums written</u> for the years 2005, 2006 presents a mixed picture. The greek insurance enterprises for the year 2006 **fall** by **3,2%** in the non-life insurance sector while they **mark progress** of **31,1%** in the life insurance sector. The gross premiums written of the foreign insurance enterprises **are increased by 10,2%** in the non-life insurance sector, whereas the respective change in the life insurance sector is **0,2% marginal increase** (*Table 4*).

The <u>investments</u> level of the insurance enterprises presents different trends by comparing the years 2005 and 2006. In 2006, the investments on fixed capital assets record an **increase** of **205,4%**, which becomes from both the greek and the foreign insurance enterprises. The investments on construction expenses **are** also **raised** in 2006 by **68,9%**, mainly due to increase of this type of investments in the greek insurance enterprises and especially in the foreign enterprises. The investments on other assets **are decreased** by **42,5%** in year 2006 compared to the year 2005 (*Table 5*).

The <u>sales</u> of assets of the insurance enterprises appear to **be reduced** in 2006 compared to 2005. Specifically, the sales of fixed capital assets **fall with rate 3,7%** and the sales of other assets **are decreased** by **52,5%** (*Table 6*).


